GUIDELINES AND VERIFICATION

ELIGIBILITY

- Must be a dependent of an active Roofers Local 26 Union Member.
- Dependents of NWIRCA Current Contractor Member's full time supervisory and office personnel are also eligible, as long as Industry Fund contributions have been received in the current year, prior to the application deadline.
- Must be a graduating high school senior or currently enrolled in an accredited college, junior college, business or trade school.
- Must have maintained a minimum 3.0 average, or its equivalent, no exceptions.
- If the applicant has previously been awarded **two scholarships** from the Association, he/she is ineligible for further consideration.

SCHOLARSHIPS

Awards will be issued jointly to the student and the school before the beginning of the school year.

CRITERIA

The Selection Committee will award scholarships based on academic excellence, extracurricular activities, community service, citizenship, leadership, and letters of recommendation.

PROCEDURE

Student must complete and sign the SCHOLARSHIP APPLICATION. A school transcript including the student's grades for the current year must accompany all applications. College students may elect to also include a high school transcript.

TWO TEACHER OR PROFESSIONAL RECOMMENDATIONS (FORM B) must be completed and submitted to the address indicated on the Instructions for Teacher Recommendations. All student recommendations must be on school letterhead; full contact information must be included for the person submitting the recommendation in order to be accepted.

Completed application consists of:

- 1. Scholarship Application.
- 2. Student's transcript.
- 3. Two Teacher/Professional Recommendations.

The responsibility of submitting a completed application ON TIME rests with the applicant. YOU SHOULD CONFIRM WITH YOUR SCHOOL AND TEACHERS THAT YOUR TRANSCRIPT AND RECOMMENDATIONS HAVE BEEN MAILED.

DEADLINE

All applications must be postmarked by Saturday, June 15, 2024. This is an absolute deadline; if applications have not been postmarked or are incomplete by the deadline, they will not be considered.
